The type of personal information we collect:

We currently collect and process the following information:

- Full name
- Contact details (telephone numbers and email address)
- Date of birth
- Passport style photograph (for photographic accreditation certificates and cards)
- Address (for invoicing purposes, where you are personally finding the training yourself, not through your employer or agent).

How we get the personal information and why we have it:

Most of the personal information we process is provided to us directly by you for one of the following reasons:

- To enlist onto a training course
- So that we can make contact with you
- When you make an enquiry into our courses
- So that we can inform awarding bodies that you have successfully completed and passed a training course.
- So that we can inform your employer the outcome of your training.

We also receive personal information indirectly from your employer or agent who has arranged for you to attend the training on your behalf.

We use the information that you have given us in order to fulfil our commitment to provide training services. We may share this information with your employer and the awarding body.

Under the General Data Protection Regulation (GDPR), the lawful bases we rely on for processing this information are:

- a) Your consent. You are able to remove your consent at any time. You can do this by contacting the Data Protection Officer.
- b) We have a contractual obligation.
- c) We have a vital interest.
- d) We have a legitimate interest.

How we store your personal information:

Your information is securely stored on our internal platforms which include CRM systems, emails, and other internal databases for the purpose of providing a service.

We keep personal information for the following timescales before it is disposed of:

How your data will be deleted:

On an annual basis the company will review the personal data held on its systems to ensure that the timescales above are met. Should your data be due for deletion, it will be removed from all systems, emails, and databases.

Erasure of your data can be requested prior to the above timescales and must be requested by contacting compliance@goldtaptraining.co.uk.

Your data protection rights:

Under data protection law, you have rights including:

- Your right of access You have the right to ask us for copies of your personal information.
- Your right to rectification You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.
- Your right to erasure You have the right to ask us to erase your personal information in certain circumstances.
- Your right to restriction of processing You have the right to ask us to restrict the processing of your personal information in certain circumstances.
- Your right to object to processing You have the right to object to the processing of your personal information in certain circumstances.
- Your right to data portability You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.
- You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
